Westbrook Together Days is now accepting Vendor Applications for the 44th Annual Westbrook Together Days, which will be held June 6 & June 7, 2025, at Westbrook's Riverbank Park. There are no rain dates. Please join us in celebrating another successful weekend as Westbrook and neighboring communities come together for our annual festival.

Similar to years past, the placement of a vehicle/trailer with axles on the grass will not be allowed. Vendors with this type of setup will be arranged along the park road in a single file. Please check in at the Chamber Booth for your setup location. Vehicles will be allowed to drop off and pick up only before and after the event.

**NO VEHICLE TRAFFIC WILL BE ALLOWED DURING EVENT HOURS. THIS WILL BE STRICTLY ENFORCED.**

In an effort to provide an atmosphere more beneficial to fundraising for local organizations, we will limit the number of duplicate items/vendors.

The following is the non-refundable fee structure for one standard space, approx. 10' X 10'. Additional space used may be subject to an additional fee. Contact the vendor coordinator for questions.

**New this year.** Non-Profit Organizations providing info. only will not be charged a vendor fee.

**Non-profit vendors raising funds:**

\$100.00 if received before June 4, 2025, \$150.00 thereafter.

**Professional/Business Vendors:**

\$250.00 if received before June 4, 2025, \$300.00 thereafter.

All vendor spots include 1- 20A 110v electric outlet. 220v available for \$50 additional fee.

- Please note all vendors will need to provide all electrical cords and water hoses for their needs. All 220v elec. cords need to have the male 4-prong L30 twist loc plug. No direct connections.

Spaces are limited, so if you plan to participate in this year's event, return the enclosed application, together with your payment, release form, and insurance certificate, prior to **June 4, 2025**.

### FESTIVAL GUIDELINES & REQUIREMENTS

1. Upon arrival for setup check in at Chamber Booth for assigned location. No vehicle traffic in the park during festival hours. (see below for times)

Set up hours: Friday, June 6th 10:00AM to 3:00 PM

Saturday, June 7 7:00AM to 8:30 AM (road closure at 8:30 for parade)

Festival hours: Friday 4:00 PM to 9:00 PM

Saturday 10:00 AM to 9:00 PM

2. All vendors are required to always have their booths manned & operational during festival hours.

3. No items are to be taped, nailed or stapled to any tree or pole in the park

4. No alcoholic beverages, silly string, smoke or stink bombs, toy guns, knives, swords, fireworks will be allowed.

5. The sale of or prizes given of drug or smoking related or any questionable items will not be permitted.

6. No parking will be permitted in the park during festival hours.

7. Overnight security will be provided from Thursday 8PM to 6AM Fri and 9PM Fri to 6AM Sat.

8. Complimentary handouts or prizes should be in good taste and not insulting or harmful to others.

**9. Insurance, naming City of Westbrook, ME 2 York St. Westbrook, ME 04092, and Westbrook Together, PO Box 1223 Westbrook, ME 04098 as additional insureds, is required for all food vendors as well as some activities with perceived liability. Contact the vendor coordinator for any questions.**

10. Any exterior signage shall not interfere with public walkway(s).

11. Vendors will not be allowed to sell their wares outside of the assigned space. No roaming.

12. In consideration of organizations raising funds, free giveaways of competing vendor items will not be allowed.

13. WTD Committee reserves the right to cancel any or all events due to weather or safety concerns without refund of vendor fees.

The decision of the Vendor Committee regarding any issues will be final. Any violation of festival rules is grounds for immediate removal from the park without a refund of fees paid.
